**Meeting** called to order at 7:00 pm by Supervisor Fred Lindsey.

**Roll Call:** Fred Lindsey, Suzy Scott, Carol Havrilla, Tom McCauley, and John Miller.

**Public Comment:** Tim Flanigan wants signs put up on Granger Road to deter snowmobiles and/or automobiles from drag racing down the road, far exceeding the 55 mph speed limit. Lindsey informed him that that he would have to address the County Road Commission regarding posting signs, but that he (Lindsey) would talk to the Road Commission on Flanigan's behalf.
